

Monthly Membership Agreement & Credit Card Authorization

In exchange for ninety-nine dollars (\$99) per month, I authorize Amplify Networking to register me into the Amplify Networking platform as a monthly member.

The initial membership commitment is \$297 for the first 3 months, which will be autobilled at \$99 per month.
